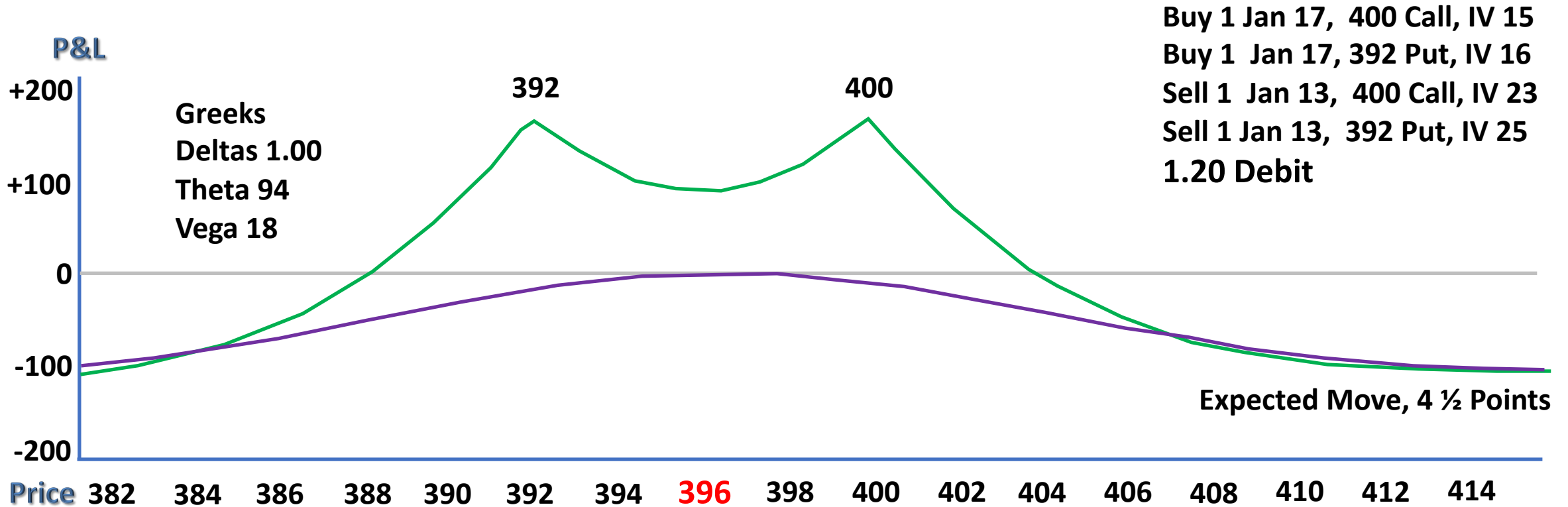

- Duration of Long and Short Strikes (Width)?
- Dollar Allocation for this Trade?
- Executing this trade? Time of the Day?
- Risk Management: Profit Target? Max Loss? Adjustments?
- Exiting this Trade? Limit or Stop Loss Order?
